THE ENTITY WAS SUBSEQUENTLY INCORPORATED AS A NON-PROFIT AGENCY BY A VOLUNTEER BOARD OF DIRECTORS UNDER THE NAME FAMILY SERVICE OF CECIL COUNTY, MD IN 1982. IN 1998, THE AGENCY WAS RENAMED FAMILY SERVICES ASSOCIATION, INC. (FSAI) TO REFLECT THE EXPANSION OF THE AGENCIES SERVICES AND THE BREADTH OF THE CUSTOMER BASE BOTH WITHIN AND BEYOND CECIL COUNTY. FSAI BECAME AN AFFILIATE OF HOLCOMB BEHAVIORAL HEALTH SYSTEMS IN JULY OF 2002. IN APRIL 2007, THE AGENCY CELEBRATED 85 YEARS OF SERVICES TO THE COUNTY AND 25 YEARS AS A PRIVATE AGENCY.
